- 1. How far away should you park from a fire hydrant? 10 ft
- 2. How far away should you park from a stop sign? 50 ft
- 3. How far away should you park from a crosswalk? 25 ft
- 4. If a bus stops on a public road to let students off, how far should you stop from the bus? 25 ft
- 5. When can you use snow studded tires in the state of New Jersey? November 15 to April 1
- 6. How fast can you pass a school bus, if the school bus is parked directly in front of school to pick up or let off children? 10 mph
- 7. If you are <u>parking downhill</u> alongside a curb, which way do you turn your wheels? <u>Towards the curb</u>
- 8. If you are <u>parking uphill</u> alongside a curb, which way do you turn your wheels? <u>Away</u> from the curb
- 9. How long do you have to report a name change (marriage, divorce, adoption)? 2 Weeks
- 10. How long do you have to report an address change? 1 week
- 11. What is the fine for failure to yield to a pedestrian in a crosswalk? \$500.00
- 12. What is the fine for littering? \$1,000.00
- 13. What is the most common type of alcohol people get pulled over for? Beer
- 14. Remember a 12oz bottle of beer, 5oz glass of wine, and 1.5oz of 86 proof liquor all have the same amount of alcohol in them.
- 15. What is a habitual offender? A <u>habitual offender</u> is a person who has 3 traffic violations in 3 years.
- 16. A truck has a 25% more chance of getting into an accident when driving in bad weather.
- 17. When can you use your high beams? During Open Country Driving
- 18. What are diamond shape signs? Warning or Construction Signs
- 19. What is hydroplaning? When your tires of your car ride on a film of water going 35mph or faster.
- 20. Every vehicle registered in New Jersey must have Liability Insurance.
- 21. What color are Rail Road Signs? Black and Yellow
- 22. If you are driving into a curve or bend your vehicle will tend to keep going straight.
- 23. How far in advance should you put your turn signal on? 100 ft
- 24. A motorist should grip the steering wheel at what position? 3 and 9 o'clock position
- 25. What is the lane called getting onto the highway? Acceleration Lane

- 26. What is the lane called getting off the highway? Deceleration
- 27. If your B.A.C. is .15%, your chances are 25 times as great getting into an accident.
- 28. Passing on the right is allowed only on roads with more than one lane going in the same direction, if vehicles on the roadway are moving in two or more substantially continuous lines or when the motorist ahead is making a left turn and there is room to pass.
- 29. <u>The Implied Consent Law</u> means that motorists on New Jersey roadways have agreed, simply by using New Jersey roadways, to submit to a breath test given by law enforcement or hospital staff following an arrest for a drinking and driving offense.
- 30. Driving under the influence of intoxicating beverages means that a driver's senses and judgment are impaired by alcohol.
- 31. B.A.C. is determined by 4 factors...
 - *Quantity of alcohol consumed
 - *Your Body Weight
 - *How quickly drinks were consumed
 - *Food eaten
- 32. Good Host Law Hosts may become involved in a lawsuit if a guest is involved in a drinking and driving collision after leaving the party.
- 33. In New Jersey, a motorists must be at least 17 years old to register a vehicle.
- 34. If a motorists has reached a BAC of slightly above <u>.05 percent</u> after drinking, the risk for causing a motor vehicle accident <u>doubles</u>.
- 35. The risk is 6 times as great when driving with a BAC of .10 percent.
- 36. The 3-seconds-plus rule is used to determine following distance.
- 37. A handheld cellular telephone may be used only in certain emergency situations which include: FIRE, TRAFFIC ACCIDENT, SERIOUS ROAD HAZARD, MEDICAL EMERGENCY, & HAZARDOUS MATERIAL EMERGENCY.
- 38. Move Over Law Requires that all drivers must move over when approaching an emergency vehicle or tow truck on the side of the road.
- 39. During the Probationary Period of a new driver, a motorist convicted of **2** or more moving violations totaling **4** or more points must enroll in the Probationary Driver Program.
- 40. Operating a motor vehicle on public or private property to avoid a traffic control signal or sign is a 2 Point moving violation.
- 41. Up to 3 points will be subtracted from a motorist's point total for every year that the motorist goes without a violation or suspension, but the point total will never be reduced below zero.
